

## Terms of use of the PartyDeco.pl online platform

- 1.** The PartyDeco.pl online platform, is available at [shop.partydeco.pl](http://shop.partydeco.pl) at and is conducted by PartyDeco Ltd. The company is located in Szczecin, in ul.Piskorskiego 11. We are registered under the Tax Identification Number: 955-235-62-19, REGON [Business Registry Number]: 321519156.
- 2.** This document describes terms of use of the [www.partydeco.pl](http://www.partydeco.pl) web-based platform. By registering you agree to all its provisions.
- 3.** The PartyDeco.pl online platform is meant for the sale of goods exclusively for entrepreneurs, previously registered in the contractors' database maintained by the owner of the platform. Registering in the database is free of any charges. The PartyDeco.pl online platform does not support consumers or entrepreneurs who have not been registered in the contractors' database. The owner of the platform reserves the right to refuse registration of some customers.
- 4.** All items offered at PartyDeco.pl online platform are brand new and free from natural and legal defects and have been legally introduced into the Polish market.
- 5.** The information contained on the PartyDeco.pl online platform does not constitute an offer within the meaning of the Civil Law. The Contractor submitting a request via means of the applications available on the online platform, makes an offer to buy a particular product under the conditions specified in the product description. The sales agreement comes at a time of confirmation of the order by the PartyDeco Customer Service.
- 6.** Prices on the PartyDeco.pl online platform are net prices. The price appearing at the time of placement of contract by the contractor is the binding price for the transaction parties.
- 7.** For each commodity we issue an invoice or receipt.
- 8.** Commodities are delivered to customers by professional courier companies. The buyer bears the delivery costs set out in the transportation price list. (See downloads).
- 9.** One of the following forms of payment is available:  
cash on delivery - to the courier upon receipt of the goods,  
bank transfer.
- 10.** For some types of goods, PartyDeco reserves the right to restrict the payment method by excluding the possibility of payment on delivery.
- 11.** In the case of non-conformity of the products, please contact our Customer Service by phone or e-mail.
- 12.** Checking the package on delivery is a prerequisite to taking account of any potential claims of the contractor for the damage or robbery of the package in transport.
- 13.** The sole owner of the marketing and promotional materials, and in particular images, catalogues, business offers and the applications listed on the PartyDeco.pl online platform is the owner of the platform and he has the full copyright to their use in all fields of use. Only registered contractors are eligible to make use of those resources, in a manner appropriate to their

characteristics and properties. Materials made available, may only be used to assist in the sale of goods purchased at PartyDeco.pl, in an unchanged form, that is in the form in which they were placed on the PartyDeco.pl platform and during the period in which the goods purchased in the PartyDeco Ltd are offered by the contractor. In the case of failure to comply with these requirements, contractors are required to immediately remove all the materials from the electronic media, websites, print-outs and any other media in which they have been used. In any case, contractors are not eligible to continue providing materials for further use by third parties.

**14.** By registering, the contractor agrees to storing and processing the personal data by the owner of the platform. Customers personal data, provided during registration is processed by PartyDeco solely for the purpose of the order and, subject to the decision of the contractor expressed during the registration, may be also used for marketing purposes. The Contractor shall have the right to access the data collected by PartyDeco, to amend, update, or correct it temporarily or permanently as well as to suspend it or demand its removal if it is incomplete, outdated, incorrect or collected in violation of the law or is no longer required for the purpose for which it was collected. The Contractor also has the right to object to the processing of personal data for marketing purposes.

**15.** By registering the contractor agrees to receive commercial information within the meaning of the Act of 18. July 2002 on electronic services (Journal of Laws of 2002 No. 144, item. 1204 as amended).

**16.** Detailed operations connected to placing orders via the PartyDeco.pl online platform, not listed above, are described in other applications at the platform.

**17.** In matters not regulated by this document, the general provisions of Polish law apply.

**18.** Proper Jurisdiction for any disputes arising from the contract is a court of relevant jurisdiction, based in Szczecin.

**19.** The author reserves the right to amend the Terms of Use at any time. Information about changes to the terms of use will be made available directly at the PartyDeco.pl platform. Using the platform after the introduction of amendments to the Terms of Use constitutes acceptance of the changes by the contractor.

**20.** The platform announces that it makes use of cookies mechanism which, by writing short text messages directly on the user's computer, allows user's identification and thus enables one to know his or her interests and needs.

**21.** Regulations come into force on 1st July 2013.

**22.** No MOQ for the first 6 months of cooperation. After this period MOQ is 500 Euro.
